PARENT CODE OF ETHICS

I hereby pledge to live up to my responsibilities as a Deltona Youth Soccer Club and FYSA parent by following the Deltona Youth Soccer Club and FYSA's Code of Ethics. This means:

- I will encourage good sportsmanship by demonstrating positive support for all players, coaches, game officials, and administrators at all times.
- I will place the emotional and physical well-being of all players ahead of any personal desire to win.
- I will support the coaches, officials, and administrators working with my child, in order to encourage a positive and enjoyable experience for all.
- I will remember that the game is for the players, not for the adults.
- I will ask my child to treat other players, coaches, game officials, administrators, and fans with respect.
- I will always be positive.
- I will always allow the coach to be the only coach.
- I will not get into arguments with the opposing team's parents, players, or coaches.
- I will treat my club and team parents, players and coaches with respect at all times.
- I will not come onto the field for any reason during the game.
- I will not criticize game officials.
- I shall not possess, consume or distribute before, during or after any game or at any other time at the field and/or game complex alcohol, tobacco, illegal drugs or unauthorized prescription drugs.
- I will refrain from any activity or conduct that may be detrimental or reflect adversely upon my team, my club or FYSA, its members or its programs.

Failure to comply with the above code of ethics may result in the suspension of your privilege to participate in club or FYSA sanctioned events, for the following periods:

- 1st offense: suspension for a minimum of thirty (30) days to a maximum of five (5) years.
- 2nd offense: suspension for a minimum of one (1) year to a maximum of ten (10) years.
- 3rd offense: suspension for a minimum of five (5) years to a maximum of fifty (50) years.

PLAYER CODE OF ETHICS

I hereby pledge to live up to my responsibilities as a Deltona Youth Soccer Club and FYSA player by following the Deltona Youth Soccer Club and FYSA's Code of Ethics. This means

- I will encourage good sportsmanship from fellow players, coaches, officials and parents at all times.
- I will always remember that soccer is an opportunity to learn and have fun.
- I deserve to play in an environment that is free of drugs, tobacco and alcohol: and expect everyone to refrain from their use at all soccer training and games.
- I will do the best I can each day, remembering that all players have talents and weaknesses the same as I do.
- I will treat my coaches, game officials, other administrators, spectators, opposing team players and coaches and my own team's players and coaches with respect at all times; regardless of race, sex, creed or abilities.
- I will concentrate on playing soccer, always giving my best effort.
- I will play by the rules at all times.
- I will at all times control my temper, resisting any temptation to retaliate.
- My conduct during competition towards play of the game and all officials shall be in accordance with appropriate behavior, FIFA'S Laws of The Game, FYSA rules, and club rules and guidelines.
- While traveling, I will conduct myself so as to be a credit to myself, my team, and my club.
- I will not possess, consumed or distributed before, during or after any game or at any time at the field and/or game complex alcohol, illegal drugs, tobacco products or unauthorized prescription drugs.

I understand that should I break any of the above rules, I can be brought before the DYSC's Ethics Committee for disciplinary actions.

Discipline actions can range from a warning to permanent pulling of the player's pass.
